Bluebook Testing Application

Your students must have the most recent version of Bluebook installed on their devices to complete testing. Please check out the most recent <u>Bluebook updates</u> before you begin testing. Conducting a digital readiness check is a good way to verify that students have the most up-to-date version of Bluebook installed on their devices.

Students have 3 ways to get their scores:

- BigFuture School mobile app- A free mobile app that lets you view scores and get customized career information.
- Downloadable PDF- Schools have access to the downloadable PDF score reports for their students through the online K-12 score reporting portal.
- College Board account- Students may choose to create or access their College Board account at <u>Student Score Reports (collegeboard.org)</u>

Accommodations in SDMS and Test Day Toolkit

When registration files are submitted, College Board will attempt to match the registration data to a student's record in SSD Online so that their accommodations populate in SDMS and Test Day Toolkit. There are several reasons why a match may not occur when registration data is being processed or when the force add functionality is used in SDMS. Submitting an Irregularity Report (IR)

The process for submitting an Irregularity Report (IR) no longer requires returning a paper form! You will need to fill out an Irregularity Report (IR) for any incidents that occur during the testing event in Test Day Toolkit at <u>Test Day Toolkit | The College Board</u>. Be sure to review the <u>Spring 2024 SAT Suite</u> <u>Retesting and Irregularities Guide</u> before you begin testing.

Support for Test Coordinators

District and school test coordinators are invited to join College Board staff during Ohio SAT School Day Office Hours which are on Thursdays from 10:30 - 11:30 a.m. via Zoom if they have questions or need support with their planning and test administration.

Fee Waivers for Eligible Students

College Board provides <u>fee waivers for income-eligible students</u> to take the SAT during a weekend administration. Additional benefits of fee waivers include unlimited free score sends, college application fee waivers, and College Scholarship Service (CSS) Profile sharing free of charge.

If your school has unused fee waiver codes from previous years, those codes are still active and can be distributed to eligible students. Fee waiver code files that were distributed in previous years can be accessed in the Download Center of your school's K-12 Assessment Reporting Portal.

If your school needs additional fee waiver codes to distribute, you can contact College Board Support at 866-609-2205.

This year, College Board also launched a program <u>where students can request fee waivers on their own</u>, without involving anyone from their school. Students can access this request process at this link. <u>SAT Fee</u> <u>Waivers – SAT Suite | College Board</u>

If any income-eligible student would like to take the May or June SAT Weekend assessments, they should get access to a fee waiver and register for the test in March.
