



Digital PSAT 10 at a Glance

The PSAT^m 10 is a part of the SAT[@] Suite of Assessments and is taken in the spring by students in grade 10.

Questions on the PSAT 10 are structured similarly to those on the SAT, focusing on the reading, writing, and math skills your teen is learning in school.

Help Your Teen Know Where to Go

The PSAT 10 is more than good practice for the SAT. The insights gained can help power your teen's path to college and career. Your teen will:



Have New Ways to Access Their Scores: Your teen can receive scores quickly and directly through the **BigFuture® School** mobile app. Your teen may also receive a PDF score report directly from their school.



See Where They Are and Set a Target: Your teen will get insights about their knowledge and skills while they have plenty of time to improve. If they've taken other assessments in the SAT Suite, they can compare their progress and then set a target SAT score based on their goals.



Find Out About Their Likelihood to Succeed in AP:

Using their personalized score report, your teen will get recommendations about what **AP® courses** might be a good fit for them.



Gain Career Insights: Beginning in 2024, the score report will map the math and reading and writing skills measured by the SAT Suite to knowledge, skills, and abilities for occupations in the U.S. Department of Labor's O*NET database. Developed with experts, the personalized career information on the report and in the mobile app aims to spark an interest in careers. As always, students can choose to log on to their personal College Board account for more in-depth exploration.

NEW DIGITAL FORMAT

In spring 2024, the PSAT 10 and SAT transition to a digital format. Going digital means an easier testing experience for students **Bluebook™**, College Board's new digital testing app. Students will have more time per question, shorter reading passages, and access to a built-in graphing calculator that can be used on the entire math section.

To become familiar with the digital format, your teen will have access to full-length practice tests in Bluebook as well as access to free **Official Digital SAT Prep on Khan Academy**[®].

Connect to Colleges and Scholarships: Through the new, free Connections[™] program^{*}, your teen can choose to hear directly from nonprofit colleges and scholarship programs that that are interested in students like them—without having to share any personal information. Messages are delivered to them through the BigFuture

School app and, when available, by mail.



Get Help to Pay for College: Taking the PSAT 10 gives students the chance to access over \$300 million in scholarship opportunities.
